This amendment is only applicable to the J/24 class to provide only additional information regarding the District 19 Championship. Refer to the PSSC Notice of Race and Sailing Instructions in conjunction for complete information.

#### **RULES**

The CYC PSSC (Small Boat) regatta is the parent event. All CYC PSSC (Small Boat) event rules and Sailing Instructions shall apply unless amended.

All J/24 class boats are eligible to compete in the CYC PSSC (Small Boat) "parent regatta" and will compete on the same course with the same start in one category. All entrants will be competing for the CYC PSSC (SMALL BOAT) trophy, and only boats/crews that meet the eligibility specifications below will compete for the District Championship trophy and be eligible for a Worlds qualifying berth. All boats are expected to be compliant with current International J/24 Class Association Rules.

#### J/24 DISTRICT 19 CHAMPIONSHIPS

The 2023 J/24 District 19 Championship shall be run concurrently and in conjunction with the CYC PSSC (SMALL BOAT) "parent" regatta. All boats competing for the District Championship must enter the CYC PSSC (SMALL BOAT) regatta per CYC requirements. J/24 Fleet 26 shall manage the District 19 Championship entrants, certification compliance, crew declaration and weight verification, and results as a separate category of the CYC PSSC (SMALL BOAT) J/24 class.

#### **ELIGIBILITY AND ENTRY:**

Whereas all J/24 BOATS are welcome to participate in the CYC PSSC (SMALL BOAT) Regatta, only those boats that meet the following criteria will be eligible for and have their results scored in the 2023 J/24 District 19 Championship. Boats that are using the CYC PSSC (SMALL BOAT) regatta for placement in this District 19 Championship, in addition to registering for CYC PSSC (SMALL BOAT), will need the following:

- Current IJCA full membership in the country they represent for the boat owner and helmsperson,
- Current fleet membership (for Fleet 26 qualifying berth) for the helmsperson,
- Provide a printed copy of a currently valid measurement certificate, including optional equipment form C,
- Proof of current marine liability insurance coverage to the value of \$300,000 (US Dollars), and
- Declare full names and verify the total weight of all crew members participating.

### **REGISTRATION: J/24 SKIPPER AND CREW**

If there are co-skippers, one shall be designated as the primary skipper for the J/24 District 19 Championship.

Crew declared for this event shall remain the same throughout the event. Emergency changes may be made only with written permission from one of the District 19 Championship organizers (Melanie Edwards or Jakob Lichtenberg).
